### **COBA**

There is an application to merge all Oakville ACBL-sanctioned clubs into COBA. Under the current rules, each club has one vote and this is seen as being an imbalance since some clubs are much bigger than others in terms of size of games and number of games per week that they have. To change this rule requires amending the constitution, but it appears that a written constitution does not exist. A sample constitution was put together by Murray Shapcott. Gord Ellis suggested that COBA adopts the constitution that the Niagara District currently uses. Chuck Renaud looked at Niagara's constitution and suggested there be 2 representatives per club with an extra one based on how many games were run at the club. Wiebe Hoogland agreed to work with Chuck Renaud to discuss the issues with the Oakville Clubs.
