NOTES TO FINANCIAL STATEMENTS August 31, 2007

The aims and objectives of the Unit are as follows:

- 1 To preserve and promote the best interests of competitive contract bridge.
- 2 To co-operate with and assist the A.C.B.L. in the promoting and conducting of bridge tournaments.
- 3 To prescribe rules of eligibility for participation in tournaments held under its auspices and to deal with reports of dishonest, unethical or improper conduct of participants in such tournaments and to take appropriate disciplinary action.
- 4 To promote the development and organization of affiliated clubs within the Unit.
- 5 To promote and support the A.C.B.L. education programme within the Unit.
- 6 To conduct such other activities as may be in keeping with its principle objectives.

NOTE 1 - SIGNIFICANT ACCOUNTING POLICIES

The financial statements have been prepared in accordance with Canadian generally accepted accounting principles and reflect the following policies:

- a Unit 166 of the A.C.B.L. follows the deferral method of fund accounting for revenue.
- b Purchased capital assets are recorded at cost and are amortized on a straight-line basis over 5 years.
- c Short-term investments consist of Bank of Nova Scotia Bonds and are recorded at market value.
- d Volunteers contribute services at all Unit run bridge tournaments. Because of the difficulty of determining their market value, contributed services are not recognized in the financial statements.
- e There are no related party transactions.

NOTE 2 - SHORT-TERM INVESTMENTS

The short-term investments consist of Government of Canada bonds purchased at a cost of \$35,000 in March 2002 maturing in March 2008 at a value of \$47,784.

NOTE 4 - LONG-TERM INVESTMENTS

The long-term investments consist of Bank of Nova Scotia bonds purchased in December 2006 at a cost of \$59,772 bearing various interest rates and maturing in December 2009, Province of Manitoba bonds purchased at a cost of \$65,000 in December 2005 and maturing in April 2011 and 4,000 shares of Talvest Money Market Fund Premium Class purchased in December 2006 at a cost of \$40,000.

NOTE 5 - ASSOCIATION RESERVES

In 1973 Unit 166 decided to establish a Reserve Fund into which the Associations in the Unit would deposit their excess surplus funds over an agreed amount. These funds are to be invested and held to credit of the various Associations. The Fund was established in 1974. At August 31 the fund was made up as follows:

DEFENDERS' CORNER:

Leading a Singleton By Audrey Grant

(Reprinted from Better Bridge with the permission of the Publisher)

Bridge writers hold strong opinions about the lead of a singleton against a trump contract. In *Card PlayTechnique*, Victor Mollo and Nico Gardener write: "Of all leads the most dynamic is a singleton. Partner wins with the ace and gives us a ruff. Or else, declarer takes the trick, but has to let partner in, while we have a trump, and the result is the same."

Of course, leading a singleton doesn't always work out so well. As Watson says in *The Play Of The Hand*: "Shortsuit leads against a suit are about the most paradoxical of all opening leads. If they succeed, they are crowned with glory, but if they fail, they deserve only ashes."

How can we make sure that our singleton leads are effective? First, we need to recognize the right time to lead a singleton. Second, we must realize that getting a ruff on defence is a partnership effort, and a key component of that effort is the suit preference signal.

Suit Preference

Choosing the right time to lead our short suit is only the beginning of good defence. We'll need partner to cooperate and we will often need to make use of suit preference signals.

The Right Time

The main reason we lead a singleton is that we are hoping partner can win a trick and return the suit for us to trump. This means that we must expect partner to gain the lead before declarer has had the opportunity to draw all our trumps.

What would raise our expectation that partner can gain the lead? If partner has bid a suit during the auction, we can anticipate that partner has some strength in the suit. If our hand is weak and the opponents have stopped short of game or slam, we can assume partner has most of the strength for our side. If the opponents have not bid the suit in which we hold a singleton, there is a reasonable prospect that partner has some strength there. In other words, we have to consider the auction and take a look at our hand to determine whether to lead a short suit.

Suppose we are sitting West and have to find a lead from this hand against four hearts...

Leading our singleton diamond is reasonable after this auction. We only have two high-card points and the opponents have stopped in game, so we can expect partner to have some high cards. Diamonds is an unbid suit and no other lead looks particularly attractive. So, we lead the eight of diamonds and this is what we see when dummy comes down...

Things get off to a good start when partner wins the first trick with the ace of diamonds and returns a diamond for us to trump. So far, so good. Our side has two tricks, but we need two more to defeat the contract and we can see one of the disadvantages of leading our short suit. We've driven out partner's ace of diamonds and dummy's remaining diamonds are established as winners.


If we can get back to partner's hand so that partner can lead a third diamond for us to ruff, all will be well...we'll get the crown rather than the ashes. With no clue from the auction, should we lead a spade or a club? It appears to be a pure guess. In this situation, however, partner can tell us what to lead!

The message can be sent in the diamond suit itself. Thinking ahead, partner can foresee the dilemma we'll have after trumping the second trick. The way the defenders communicate in these situations is to give a suit preference signal using the card that is led back. Not counting the trump suit, there are only two suits to consider: spades and clubs.

SUIT PREFERENCE SIGNAL

- A high-ranking card asks for the higher-ranking suit.
- A low-ranking card asks for the lower-ranking suit.

Suppose this is the complete deal:



Holding the ace of diamonds, partner wins it and returns the ten, asking for the higher-ranking of the two suits. We lead a spade, partner wins the ace, and leads another diamond for us to ruff. We take the first four tricks to defeat the contract. We had to lead our singleton and then had to return a spade after getting our first ruff. Suppose this were the deal:

Now partner would win the ace of diamonds and return the two, a suit preference signal for the lower-ranking suit, clubs. We lead back a club and partner wins the ace and returns another diamond to give us a second ruff and defeat the contract. If we had led back a spade, declarer would make the contract.



The play of this hand is sure to present all sorts of problems for both declarers since the auctions make it apparent that the suits will, in all likelihood, not be breaking favourably. Even if the loss of two trump tricks can be prevented there is still the club problem to navigate . Five trump winners plus four club tricks assuming locating the club jack - still adds up to only nine tricks, so declarer must still establish and cash a red trick to bring the total to ten without losing trump control. Three-two trumps would be a blessing but declarer could also work around a couple of the 4-1 splits as long as the queen-jack to four spades are not offside. Care and planning, however, must be taken in attacking trumps if they are jack-eight or queen-eight to four in West.

The good, but non-expert, player will do some planning and proceed to attack the hand without realizing they have swept under the rug the deal's key problem. If trumps are 4-1, then declarer can not afford to get 'tapped' three times (once on the opening lead; once when conceding a trick to the jack or queen of spades as trumps are drawn; and once when the opponents win the club ace).

If the initial heart attack has set up a three-tap scenario, then declarer won't be able to stand trumps to be 4-I — but how is declarer expected to know what is necessary? Believe it or not, it is declarer's first play from the dummy that is the key one in answering this important question.

With East having almost all of the opponents' high-card assets, perhaps we can use dummy's heart spots to

cause him problems. Clearly, declarer won't be able to survive if East has the ace-king-jack of hearts (or even the unlikely ace-jack or king-jack). Why is this, you say? Because the defenders can sacrifice a heart trick (setting up a non-useful winner in the dummy), if by doing so, they succeed in tapping declarer three times. This tapout will develop an extra trump winner for the defender that started with four trumps (undoubtedly that opponent will be West).

There is, however, one heart position where declarer has control over his own destiny. That is jack-nine fourth with West, the opening leader. But dummy's heart eight — a small fish in a big pond — must be played at trick one or all will be lost (fans of old television sitcoms can probably hear the chorus from Gilligan's Island playing in the background — "... or the Minnow would be lost").

When the eight forces the ace or king, the expert declarer can start thinking about 4-I trumps since the triple tap seems to be preventable. Playing low from the dummy is an error as it enables the defence to insert a covering spot card, hence resurrecting the triple-tap scenario.

So, ruff the first trick and cash the trump ace. The appearance of East's queen of spades makes it inadvisable to cash the other high trump as West's original jack-eight to four would then spell sure defeat. East's queen is also more likely to be singleton than it is a

choice of plays from queen-jack doubleton – both the auction and 'Restricted Choice' argue for this.

Therefore declarer's second trump play should be low toward dummy's ten. West can do nothing better than to win his jack. Note: losing to the queen-jack doubleton in the East hand wouldn't be the end of the world as we would still have our five planned-for trump tricks. It might even give us a clearer idea of how to play the club suit for four tricks.

What can the defence do at trick three upon winning their trump trick in the West hand? Answer: virtually nothing constructive. A heart continuation, with the jack marked onside, will set up a heart winner for declarer (there is the red suit winner that declarer needs to fulfill his contract which we talked about earlier). A diamond switch does the same thing, while a club play just finds the jack for the offence.

The key to the deal is forcing the defence to set up a heart winner, if the defence does that for declarer, after only two taps, not three. Then it is a useful trick. Finally, if the defence refuses to lead more hearts to set up the queen in dummy, declarer will have the time to get a diamond trick.

DUCK SOUP By Jack Shinehoft

This deal from the Spingold at the recent Las Vegas Nationals was rather intricate. I don't know what, if anything, you call this play, but it had never happened to me before. You are East...

...and see the following auction:

West	North	East	South

- 2. 3+ diamonds
- 3. 3-card limit raise

Your partner leads the three of clubs, dummy plays low and you insert the king which loses to declarer's ace. Declarer then plays a low spade to the queen, partner showing out with the seven of diamonds. What do you do? How do you defeat this seemingly-impregnable contract?

You'll need a little bit of help from declarer but you have a chance. You have to duck this trick. Declarer then leads the five of spades from dummy and you have to duck again, covering the five with the seven. Declarer wins

this in his hand with the eight, and leads a third spade.

You must duck a third time. Declarer now leads a heart to his king, (the only mistake he made) and a high spade from his hand. You have to win this trick and return the jack of hearts locking declarer in the dummy. He plays a third heart to which you follow and then the fourth heart which you ruff with the nine of spades. Partner has discarded all his clubs save the queen and keeps his diamonds. Declarer now has to lose two diamonds, a club and the ace of trumps. An interesting hand indeed.

The full deal:

It is not intuitively obvious, but declarer can make the hand by leading a club from dummy after the third spade is ducked. Then he scores four spades, three hearts as you helplessly follow suit, the ace of diamonds and two club tricks. West can make declarer guess the distribution if he shifts to a diamond upon winning the club queen, declarer ducking once and then continuing trumps, or playing his winners for discards immediately.

SOCIAL BRIDGE 2008

It's Spring and the Yarborough Club of the Toronto area is winding down its 45th season of individual competition in 8-man format. Once again a hand was dealt that tested a variety of skills and gave rise to considerable discussion.

Dealer North. Neither Vul.


In both rooms the bidding started one diamond-two clubs-two diamonds. In one room South jumped to six no trump and played there. In the other room the bidding went four no trump (1430)-five hearts-five no trump-?

North reasoned that South was interested in a grand slam and if he responded six diamonds it might be passed so he bid seven diamonds and played there. The post-game discussion suggested that South should not have asked for kings since he had no interest in bidding the grand slam.

So let's assume you are the declarer in six no trump. Plan the play after the lead of the heart queen.

If you are familiar with safety plays, you may win in dummy and lead a low diamond intending to play the jack if East plays low. If so, your contract is almost guaranteed.

So now to the actual situation. Put yourself in East's shoes and consider your defence after West leads the heart queen, dummy wins and leads a small diamond:




It is not too difficult to decide to rise with the queen, and while the next lead may be less obvious to some, you must attack dummy's only possible outside entry by leading a club.

Well bid, well played and well defended for no swing.

And the last word comes from the two of clubs. "If I had been in the North hand instead of my cousin the two of hearts, the contract would have been unbeatable".

Not quite the last word. If the spade king had been onside, declarer was cold on a non-simultaneous double squeeze anyway, provided he does not take the spade finesse too early. The ending would be:



On the final club, West discards a heart, dummy a spade and East must release a spade to guard the diamonds. Declarer then cashes the ace and king of diamonds discarding his heart eight, forcing two spade pitches from West. South will now score all three spades with the aid of the finesse. Note that declarer needs the nine of hearts in the dummy at the end, and both spades, one to discard and one to lead. — Ed.

Hi John:

Thank-you so very much for making it possible for Phil and Ali to attend the Youth NABC in Atlanta last weekend. It was a growth experience for them in many ways. In terms of Bridge, they learned that there is a whole higher level of play to

aspire to. According to Phil, they were in the top third of their Division (one to three years playing experience) in the morning session, and somewhat closer to the bottom in the afternoon session. From a parental point of view, this experience lends itself to several important lessons in life: while natural talent and ability is important, it must be coupled with practice to achieve at higher levels. Also, like any other activity Phil has been involved in hockey for example - one can be at the top of one league and then not so near the top after moving up a level. At the same time, we know both Phil and Ali really enjoyed the Bridge they played, and weren't dismayed when faced with more experienced players.

Another aspect of the experience that was wonderful for Phil particularly was the opportunity to learn first-hand about another country's culture and traditions. Having never been south of the Canada/U.S. border, it was great for him to take part in and overhear conversations with everyone we met during our stay. As

Doreen knows, the group of three Canadian chaperone families and charges was able to make the trip Saturday night to Stone Mountain and watch the Independence Day weekend laser show/fireworks display. It was both amazing and educational for kids and parents alike.

Our most heartfelt gratitude for these wonderful experiences for both our kids, and ourselves.

The ACBL and School Bridge League are amazing organizations, and we were thrilled for our family and Ali to be a part of this experience.

Thank you so much for including me in your get together today. I enjoyed it thoroughly and learned and reviewed lots of useful things. My experience in teaching bridge is very limited, certainly compared with some of the participants

The title is Intermediate Bridge which to me means that I can teach whatever I please. I have decided to start with your book and materials called Competitive Bidding and see where that takes us. I am very confident that all the support materials will make this a manageable task.

I particularly admire the way in which you don't pretend you know everything and defer to the experts. You really do that very well. My only previous experience teaching bridge was this past spring in which I did a course called Beginners Bridge and I used Bridge Basics 1 materials. I frequently used the expression "Audrey says..." and I felt that my students appreciated that this meant that I wasn't trying to pretend that I knew it all either. Those students absolutely loved the book, the cards and the way the course was sequenced. I hope the next one goes as well.






